21 <u>DRAFT BRAINTREE DISTRICT LOCAL PLAN FOR CONSULTATION</u>

INFORMATION: Councillor Mrs L Bowers-Flint, Chairman of the Local Plan Sub-Committee, introduced this Item.

The Council had been working on a new Local Plan to guide development in the District up to 2033. The document would include strategic and non-strategic policies and allocations and, once adopted, it would replace the Braintree District Local Plan Review 2005 and Core Strategy from 2011. As part of the Local Plan, the Council was required to boost significantly the supply of housing, as set out in the National Planning Policy Framework.

Since March 2016, the Local Plan Sub-Committee had met to consider the total number of new homes to be provided; a broad spatial development strategy; and to recommend the allocation of development sites within town and villages in the District. At its meeting on 26th May 2016, the Sub-Committee had recommended that the draft Plan, including all site allocations and policies contained within it, be approved by the Council for public consultation.

The Local Plan Sub-Committee had recommended that the Local Plan should deliver the Objectively Assessed Need of 845 new homes per annum between 2016 and 2033. This required the Council to allocate land for approximately 10,000 new homes within the District over the Local Plan period, given the sites that had already been approved for development. Sites for the provision of open space, employment, education, retail and community facilities to support the new homes would also be allocated and provision made to ensure that infrastructure requirements were met. In addition to proposed policies and development site allocations in towns and villages across the District, the Plan would include a strategic section on North Essex setting out proposals for new garden communities. The Local Plan was a draft document and further changes could be made to it either in response to consultation, or from new evidence which continued to be gathered.

In conjunction with the draft Local Plan, the Council would be publishing a Sustainability Appraisal/Strategic Environmental Assessment (SA/SEA). This document assessed the environmental implications of every policy and site allocation in the Local Plan and all reasonable alternatives.

If approved by the Council, the draft Local Plan and (SA/SEA) would be subject to public consultation for a period of eight weeks from Monday, 27th June 2016 to Friday, 19th August 2016. Consultation responses would be reported to the Local Plan Sub-Committee in the Autumn and the final draft version of the Plan would be considered by the Sub-Committee and full Council in late 2016. A further period of public engagement would then take place before the draft Plan was submitted to the Planning Inspectorate for examination.

Eleven amendments to the draft Braintree District Local Plan had been submitted by Members and they had been published in an Amendment Pack prior to the meeting. The amendments were numbered 1 to 11. In accordance with the agreed process for this Special Meeting of Full Council, Councillor Mrs Bowers-Flint had agreed to accept the amendments numbered 1, 2, 3, 4, 5 and 6, as set out in Part 1 of the Amendment Pack and to move these as part of the substantive motion. No Member had requested a debate on these amendments. The amendments are set out below:-

Amend tenth bullet point by adding 'natural' before 'light', deleting 'and' before 'overlooking' and adding 'and artificial light trespass' at the end of the sentence.

The tenth bullet point to read (change underlined):-

Protect the amenity of existing and future residents and users with regard to noise, vibration, smell, loss of <u>natural</u> light, overlooking <u>and artificial light trespass</u>.

22 <u>DRAFT BRAINTREE DISTRICT LOCAL PLAN – PROPOSED CONSULTATION</u> STRATEGY

INFORMATION: Consideration was given to a report on the proposed Strategy for the forthcoming public consultation on the draft Braintree District Local Plan. Consultation would take place over an eight week period from 27th June 2016 to 19th August 2016.

In addition to contact with statutory consultees, Parish Councils, neighbouring Authorities, landowners, businesses, and people on the Local Plan database, the consultation process would include a series of exhibitions across the District; a

special edition of the Council's Contact magazine to be sent to every household; and site notices. The draft Local Plan and details of forthcoming events would be publicised in local newspapers and via social media, and copies of the draft Plan would be available to view on the Council's website, at Causeway House, Braintree and at local libraries.

Respondents would be encouraged to submit comments via the online consultation portal 'objective', although alternative written responses would also be accepted. Consultation responses, together with any further sites put forward, or proposed changes would be reported to the Local Plan Sub-Committee in the Autumn. A final round of public consultation would then take place before the Local Plan was submitted to the Planning Inspectorate for examination.

During the consideration of this report, Members were advised that an additional staffed exhibition had been arranged which would be held at Feering Community Centre, Feering on 25th July 2016 between 2.30pm and 7.30pm. It was confirmed also that the forthcoming consultation, as well as the second stage consultation, would include consultation with statutory consultees.
