To approve or not approve the HRA Screening Appraisal for inclusion within the Local Development Framework (LDF) evidence base.

## **Executive Summary:**

In order to comply with European Regulations, a Habitat Regulations Screening Report has been commissioned to look at the impact of the Pre Submission Site Allocations and Development Management Plan on the sites of European Importance. The report concludes that there are no additional impacts to be mitigated which were not considered as part of the Appropriate Assessment carried out in 2009 on the Core Strategy.

It is therefore proposed to add the Habitat Regulation Screening Report to the evidence base for the LDF which will be submitted alongside the ADMP for examination.

#### **Decision**

That the Habitats Regulation Assessment Screening Appraisal for the Braintree District Council Allocations and Development Management Plan, to be included as part of the evidence base for the Local Development Framework, be approved.

# 1. Background

- 1.1 In June 2009 a HRA Appropriate Assessment was prepared to accompany the BDC Local Development Framework (LDF) draft Core Strategy. This was part of the evidence base for the Core Strategy. Although there are no international sites within the boundary of the Braintree District, there are several sites in neighbouring authorities which have been identified as being potentially vulnerable to impacts. A proactive, precautionary approach was taken to ensure that international sites which occur nearby, on the Essex Coast, are not adversely affected by the Braintree District Core Strategy policies.
- 1.2 The following European sites were identified using a 20km area of search around Braintree as well as including sites which are potentially connected (e.g. hydrologically) beyond this distance:
- Abberton Reservoir SPA
- Blackwater Estuary SPA
- Colne Estuary SPA
- Crouch and Roach Estuaries SPA
- Hamford Water SPA

- Stour and Orwell Estuaries SPA
- Essex Estuaries Marine SAC
- Abberton Reservoir Ramsar
- Blackwater Estuary Ramsar
- Colne Estuary Ramsar
- Crouch and Roach Estuary Ramsar
- Hamford Water Ramsar
- Stour and Orwell Estuary Ramsar
- 1.3 The 2009 HRA Appropriate Assessment report concluded that 'accepting that the overall allocation for Braintree must be implemented, and given the District's distance from international sites, the specific locations of housing is of little significance to those sites. Mitigating any diffuse recreational impacts can be done in three principle ways:
- Ensuring that housing has an appropriate allocation of SANG (Sustainable Accessible Natural Greenspace);
- Monitoring levels of recreational use of sites, and provenance of users; and
- Ensuring that appropriate site management measures are in place on the international sites.
- 1.4 The report recommended that the monitoring and site management measures need to be implemented as a collective exercise with adjoining authorities where the international sites occur and can be managed. Monitoring the provenance of recreational users will also further the understanding of the spatial distribution of visitors, thereby further assisting quantification in future assessment of this type and helping identify where SANG can be most effectively placed and this has taken place over the last three years.

## 2. Screening Report of the ADMP

- 2.1 Whilst an Appropriate Assessment was carried out on the draft Core Strategy, which included the general scale and location of housing in the District. Taking the proactive, precautionary approach it was considered necessary to carry out a HRA Screening Appraisal of the Pre Submission ADMP now that the exact locations of growth and more detailed policies are set out. Consequently Lepus Consulting were commissioned to carry out this work and their draft report is available on the website to view.
- 2.2 The HRA Screening Appraisal looked at the potential significant effects which could be identified and were explored for the sites which were considered in the 2009 Appropriate Assessment. These included impacts on air quality, disturbance and recreation pressures, water resources, water quality and wastewater.
- 2.3 Subject to a minor amendment to the text of the Plan as set out in the recommended changes report to this committee, the HRA Screening Appraisal concludes that:

"This HRA report has carefully considered the effects that might be associated with development as part of the Pre-Submission Version of the BDC SADMP. There are no European sites within the Braintree District. Of those that have been identified from a 20km area of search and others that have been included through hydrological pathways that lie beyond this search zone, none are expected to experience adverse effects from proposals in the SADMP.

Issues of visual and noise disturbance from recreation and physical disturbance have been considered and mitigations suggested in the 2009 Appropriate Assessment of the BDC Core Strategy. Issues of water resources have been sufficiently considered in the 2011 Water Cycle Study and by the ESW Abberton Scheme.

The Pre-Submission Version of the SADMP is not likely to lead to adverse effects on any European sites alone or in-combination with other plans providing that mitigation measures outlined in the Core Strategy AA are implemented. There is no requirement to prepare an appropriate assessment".

2.4 The report must be sent to Natural England for their approval as a statutory consultee on all HRA's. Any changes requested by Natural England will need to be made to the Screening Appraisal and if necessary will be reported to the LDF Sub Committee

#### Recommendation

To approve the Habitats Regulation Assessment Screening Appraisal for the Braintree District Council Allocations and Development Management Plan to be included within the evidence base.
