1. Purpose of the Report

1.1 To provide an overview of the work the Braintree District Community Safety Partnership delivered during 2022/23.

2. Recommendations

2.1 For the Corporate Scrutiny Committee to review the annual report (Appendix 1) and make any recommendations to Cabinet.

3. Summary of Issues

- 3.1 The Braintree District Community Safety Partnership (CSP) is made up of representatives from Braintree District Council, Essex Police, Essex Fire & Rescue Service, National Probation Service, Mid & South Essex ICS, Essex County Council (Partnership Lead and Secondary education), Community360 and Eastlight Community Homes.
- 3.2 The Community Safety Partnership work together to protect their local communities from crime and help people to feel safer.
- 3.3 There is a statutory requirement for Community Safety Partnerships to conduct an annual strategic assessment, as per legislation in the Crime & Disorder Act Revised 2006. The assessment collates and analyses statistical and contextual data from a range of partners and is used to inform key findings and recommendations for priorities moving forward.
- 3.4 The CSP priorities for 2022/23 were:
 - Protect the vulnerable;
 - Promote healthy relationships;
 - Keep Safe online;
 - Build community resilience; and
 - Promote safety in our communities.

3.5 Key Achievements

Child Exploitation

Spot It Stop It

Work has continued to develop and expand the Spot it Stop it scheme to raise awareness of child exploitation to local businesses, sports clubs and voluntary organisations.

The scheme provides an awareness training package with the aim of increasing knowledge of child exploitation, the signs to look out for and how to report concerns. It helps to reassure the public, parents, and carers that premises are a safe place for young people to visit; that child exploitation is taken seriously and will not be tolerated.

30 youth football coaches from Braintree Football Club received Spot It Stop It training and to date more than 100 members of staff from commercial premises where young people may visit - including McDonalds, Cineworld, Premier Inn and Pizza Hut have received an input and/or training.

Local Exploitation Group

The partnership including Family Solutions, the Children's Society, Education, Essex Youth Service, Essex Police and Braintree District Council has continue to meet on a regular basis with the aim of providing early intervention to vulnerable young people at risk of Child Sexual Exploitation (CSE) or Criminal Exploitation (CE) before it escalates to a 'high risk' level.

The group coordinates partnership work and identifies local hotspots and vulnerable locations where young people are associating with each other and develops tailored and effective plans to disrupt activity. They also engage with young people to establish the areas they feel 'safe' or 'unsafe' and develop and deliver awareness campaigns aimed at children and young people, parents and carers, businesses, and the wider community.

Schools Input

Education and support

Essex County Fire & Rescue Service conducted 302 Safe and Well visits to offer personal safety advice and signpost residents to appropriate support services.

157 home fire safety checks were carried out and 115 safeguarding referrals made for vulnerable people across the year.

The Education Team delivered a total of 117 educational inputs to schools across the district, reaching 11,974 pupils focusing on key themes including Cyber Safety; Firework/Halloween Campaign; Gang Awareness and Knife Crime; Hate Crime; Healthy Relationships; 'Respect' assemblies' and road traffic and pedestrian safety, among others.

<u>'Chelsea's Story' - theatre production in schools</u>

More than 600 young people learnt about healthy relationships, consent, and exploitation after watching a powerful play organised by educational theatre group, Alter Ego Creative Solutions.

The play creatively tackled the issue of child sexual exploitation, exploring the different ways that young people can be drawn into abusive relationships and illustrating some of the consequences.

Issues covered included - What makes a healthy/unhealthy relationship; safe internet use/sexting; consent; the grooming process, Child Sexual Exploitation & the differing methods; avoiding victim blaming, and where to go for help & advice.

Domestic Abuse

'J9' Domestic Abuse training

The CSP commissioned the charity Safer Places to deliver 'J9' training, an initiative to raise awareness and to help victims of domestic abuse following the death of Janine Mundy, in Cornwall where she lived, in 2003.

Two sessions were held to help raise awareness and increase knowledge and understanding of domestic abuse for staff in the public and the voluntary sectors including GP surgeries, veterinary practices, opticians, dental practices and community organisations. A half-day session took place in November 2022, hosted by Witham Town Council. The second session took place in Braintree in February 2023.

Where the J9 logo is displayed it alerts victims that they can obtain information to help access a safe place where there can seek information and the use of a telephone.

Child to Parent Violence and Abuse course

An increase in child to parent abuse was identified by partners and Next Chapter were commissioned to deliver a specific course working with the parents, the child and any siblings. 8 young people and 3 parents completed the 12-week pilot course.

Safer Streets – Witham

Braintree District Council, in partnership with the Police, Fire & Crime Commissioner's Office for Essex (PFCC), applied for Round Four of the Safer Streets Fund from the Home Office and were successful in securing £297,202 with an additional £150,506 match funded by various members of the Braintree District Community Safety Partnership to support the bid.

The Safer Streets programme has a focus on reducing Violence against Women and Girls (VAWG), neighbourhood crime and anti-social behaviour.

Interventions delivered in 2022/23 included:

- Safer Streets survey (on-line and face to face);
- Knife Arch deployment by Essex Police at pubs;
- Promotion of Neighbourhood Watch;
- ASB Patrols;
- Property Marking Events in secondary schools and community events; and
- CARA providing 414 one-to-one specialist sexual violence therapy sessions for 43 women and girls.

Interventions for 23/24 include launch of Dog Watch, CCTV installation, improved signage, nights of action, youth diversionary project, Spot It Stop It training.

Violence and Vulnerability

The Serious Violence Duty came into effect December 2022 to ensure relevant services work together to share information and allow them to target their interventions, where possible through existing partnership structures, collaborate and plan to prevent and reduce serious violence within their local communities.

Braintree CSP continues to work with the Essex Violence and Vulnerability Unit who are in the process of developing a strategic needs assessment and data/reporting tool for each local authority area to enable them to target resources where they are most needed.

Subgroups

Community Safety Hub

Multi-agency working continues to be essential in the prevention of crime and disorder. The Braintree District Community Safety Hub continued to maximise the benefits of collaborative working with partners. Membership of the Hub has again increased during the past year and includes representation from partner organisations of the CSP, other statutory services and the voluntary sector. A number of professionals meetings have been held following initial discussions at Hub, particularly for more complex cases around anti-social behaviour, substance & alcohol misuse, mental health and vulnerability.

Domestic Abuse Subgroup

This group was established to discuss domestic abuse cases where the individual has contacted the local authority for homelessness advice, or an application made to the housing register.

Joint working between relevant agencies supports an informed assessment of risk levels and enable evaluation of appropriate measures and interventions to manage risk and explore the role of statutory homelessness functions and the housing allocation scheme.

Housing Support Subgroup

The group was established to provide a forum for information sharing and decision-making for more complex cases where a person has previously been identified as vulnerable and has caused anti-social behaviour to others, and where contact has been made with the local authority for homelessness advice or an application made to the housing register.

Where appropriate the individual concerned will be invited to attend these meetings in person to ensure they are engaged in the process and work together with professionals to determine their own action plan in a strengths-based approach.

The recommendations set out in this report will help the Council to deliver the following Corporate Objectives:

- A sustainable environment and a great place to live, work and play.
- Residents live well in healthy and resilient communities where residents feel supported.

4. Options

4.1 There are no options to consider as the strategic assessment and action plan for 22/23 is agreed by the Responsible Authority Group and sent to the Office of the Police, Fire & Crime Commissioner for Essex to enable the annual funding allocation to be released.

5. Financial Implications

- 5.1 Future work of the Community Safety Partnership will be delivered within existing resources. The CSP has an allocated budget of £17,739 for 2022/23.
- 5.2 Future work of the Safer Streets project in Witham will be delivered within existing resources and from the Home Office allocated budget.

6. Legal Implications

- 6.1 The Community Safety Partnership is a statutory partnership and must adhere to legislation.
- 6.2 The Community Safety Hub has an information sharing agreement and standard operating procedures.

7. Other Implications

7.1 The Braintree District Community Safety Partnership ensure all partners have safeguarding policies and procedures in place.

8. Equality and Diversity Implications

- 8.1 Section 149 of the Equality Act 2010 creates the public sector equality duty which requires that when the Council makes decisions it must have regard to the need to:
 - (a) Eliminate unlawful discrimination, harassment and victimisation and other behaviour prohibited by the Act
 - (b) Advance equality of opportunity between people who share a protected characteristic and those who do not
 - (c) Foster good relations between people who share a protected characteristic and those who do not including tackling prejudice and promoting understanding.
- 8.2 The protected characteristics are age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, gender and sexual orientation. The Act states that 'marriage and civil partnership' is not a relevant protected characteristic for (b) or (c) although it is relevant for (a).

The Crime and Disorder Act 1998 placed a joint responsibility upon specific agencies and other partners within the community to develop and implement strategies to protect their communities from crime and help people feel safe.

Throughout the year partners have worked together to deliver successful projects and initiatives against the identified priorities to:

- Protect the vulnerable
- Promote healthy relationships
- Keep safe online
- Build community resilience
- Promote safety in our communities

Many of these are aimed at raising awareness, education and prevention as we feel these add value to the work delivered by local agencies on a daily basis.

We are proud of the achievements the Partnership has made and look forward to another successful year.

Responsible Authority Group

The Responsible Authority Group is the strategic group of the Braintree District Community Safety Partnership and consists of strategic and operational officers who are collectively responsible for addressing crime, disorder and community safety across the Braintree District.

These organisations include Braintree District Council, Essex Police, Essex County Fire & Rescue Service, National Probation Service, NHS Mid & South Integrated Care Board, Eastlight Community Homes, Essex County Council (Education) and Community360 (voluntary sector).

The group has overall strategic responsibility for making sure that the priorities identified from the annual Strategic Assessment are outlined within the Action Plan, and the projects within the Action Plan are delivered.

Strategic Assessment

Each year the Community Safety Partnership is required to produce a Strategic Assessment report about crime and disorder levels in its area. The results of the Strategic Assessment are used by the Partnership to identify themed priorities for the coming year. The Partnership produces an Action Plan which describes how it will deliver on the identified priorities.

The Strategic Priorities for 2022-23 were:

- Protect the vulnerable
- Promote healthy relationships
- Keep safe online
- Build community resilience
- Promote safety in our communities

Funding

The Office of the Police, Fire and Crime Commissioner for Essex (OPFCC) allocated grants from its 2022–23 Community Safety Fund to all Community Safety Partnerships across the county. As in previous years the OPFCC set aside a proportion (4%) of this funding for Domestic Homicide Reviews (DHRs). This fund provides: co-ordination of the DHR process; administration of DHR panels; funding for independent chairs; lesson learning seminars; and monitoring and reporting on DHR recommendations implementation.

The funding formula is based on population size, deprivation and crime levels.

Braintree District Community Safety Partnership received a funding allocation of £17,739 for 2022-23.

Action Plan 2022-23

Braintree District Community Safety Partnership produces an annual Action Plan which underpins the priorities and sets out how local agencies will work together to meet the actions within the plan.

Actions include specific projects and initiatives put forward by partner agencies, which are then collectively agreed by the Responsible Authority Group.

Key Achievements 2022-23

Safeguarding vulnerable young people on public transport

Braintree took part in the countywide Operation Henderson campaign, a joint initiative organised by Essex Safeguarding Children Board together with British Transport Police, Essex Police, the Violence and Vulnerability Unit, Rail Operators, Essex Youth Service, local councils and The Railway Children. It aims to raise awareness of the vulnerability of young people to exploitation and abuse at stations and transport networks in parts of Essex.

Research and local data have shown transport networks are used by vulnerable young people who may be at risk of sexual exploitation, criminal exploitation and trafficking. Young people often gravitate towards stations because they are



traditionally busy, anonymous places that also provide some form of shelter and access to food and drink. Bus and rail networks can also be used by offenders to traffic young people for the purpose of sexual and criminal exploitation.

As well as members of the public, all staff working within and around a station, from ticket collectors to engineers, coffee shop workers to cleaners, play an important role in safeguarding vulnerable young people.

Spot It Stop It - raising awareness of Child Exploitation

Work has continued to develop and expand the Spot it Stop it scheme to raise awareness of child exploitation.

The scheme encourages businesses to sign up to receive awareness training to increase their knowledge of child exploitation including the signs to look out for and how to report concerns.



The training it delivers helps to reassure the public, parents and carers that premises are a safe place for young people to visit; that child exploitation is taken seriously and will not be tolerated.

30 youth football coaches from Braintree Football Club received Spot It Stop It training, delivered by Braintree District Council's Children, Young People & Safeguarding Officer. The project has also joined up with the countywide 'Operation Henderson' which aims to raise awareness of the vulnerability of young people to exploitation and abuse at stations and transport networks.

To date more than 100 members of staff from commercial premises where young people may visit - including McDonalds, Cineworld, Premier Inn and Pizza Hut – have received an input and/or training.

Mobile cameras help tackle crime and disorder

The CSP has continued to fund the purchase of mobile cameras to be deployed to areas where there is believed to be criminal or anti-social behaviour occurring. The cameras are installed by the Council's street-scene enforcement team following requests and discussion by multi-agency partners.

To date, useful evidence has been used by officers to disrupt the suspected supply of Class A drugs by known gang nominals; target prolific shoplifters; identify and



deter identified individuals from causing anti-social behaviour including fly-tipping; and to assist in gathering evidence to put in place enforcement action such as Closure Orders.

'Chelsea's Story' child exploitation theatre production in schools

More than 600 young people have learnt about healthy relationships, consent and exploitation after watching a powerful play organised by Eastlight Community Homes, and funded by the CSP.

Educational theatre group, Alter Ego Creative Solutions, performed 'Chelsea's Story' at three secondary schools in the district – New Rickstones Academy, Tabor



Academy and Notley High School - in February and March 2023.

The play creatively tackles the issue of child sexual exploitation, exploring the different ways that young people can be drawn into abusive relationships and illustrating some of the consequences.

The production tells the story of a group of students who discover the diary of a girl called Chelsea. Chelsea was a 15 year old girl who, having fallen out with her friends and family, met a guy called Gary. Gary was kind, understanding, had a nice car, had his own flat and listened to her. Unfortunately Gary was not what he seemed to be. Chelsea's story is played out and examined by the students who, along with their teacher, attempt to understand what happened to Chelsea.

Issues covered include - What makes a Healthy Relationship; What makes an Unhealthy Relationship; Safe Internet Use/Sexting; What is Consent; The Grooming Process, Child Sexual Exploitation & the differing methods; Avoiding Victim Blaming, and Where to go for help & advice.

For professionals it also raises Awareness of 'The Warning Signs of



CSE', and awareness of the journey that young people may have been on that has resulted in them being exploited – a journey that can all too easily make it seem as though they have 'made their own choices' and can leave them not seeing themselves as victims and fighting against any intervention.

Local Exploitation Group offers early intervention to young people at risk

The partnership has continued to build upon the success of its Local Exploitation Group aimed at providing early intervention to vulnerable young people at risk of Child Sexual Exploitation (CSE) or Criminal Exploitation (CE) before it escalates to a 'high risk' level.

A core group of key local partners - including Family Solutions, The Children's Society, Education, Essex Youth Service, Essex Child & Family Wellbeing Service, Essex Police and Braintree District Council - meet regularly, prior to MACE meetings, to discuss current issues and to determine whether any intervention can be implemented to avoid young people becoming involved in CSE or CE, and to escape potential perpetrators.



Aims of the group are to coordinate partnership work and identify disruption activities; identify local hotspots and vulnerable locations where young people are associating with each other; develop tailored and effective plans to deal with local hotspots; engage with young people as to what areas feel 'safe' or 'unsafe' for them and initiate action plans for these areas; and develop and deliver awareness campaigns aimed at children and young people, parents and carers, businesses and the wider community.

Previously the group has provided funding to an isolated and vulnerable young person who had been criminally exploited, to enable them to take part in dog training classes with the aim of building their confidence and self-worth.

Child to Parent Violence and Abuse course

Parents affected by abuse and violence from their own children have been given extra support thanks to a new course delivered in the district.

The 12-week course was created by Next Chapter, and delivered in partnership with Essex County Council's Family Solutions, after professionals noticed an increase in the number of families they were working with affected by the issue.



This was brought to the attention of the CSP's Community

Safety Hub, where professionals from a range of organisations meet regularly to discuss new or emerging issues that require a multi-agency solution. The CSP agreed to fund a 12-week course for identified families.

Fire service delivers education and support

Essex County Fire & Rescue Service (ECFRS), conducted 302 Safe and Well visits to offer personal safety advice and signpost residents to appropriate support services.

157 home fire safety checks were also carried out, and 115 safeguarding referrals made for vulnerable people across the year.



ECFRS' Education Officers

delivered a total of 117 educational inputs to schools across the district, reaching 11,974 pupils.

Sessions focused on key themes including Cyber Safety; Firework/Halloween Campaign; Gang Awareness and Knife Crime; Hate Crime; Healthy Relationships; 'Respect' assemblies' and road traffic and pedestrian safety, among others.

Support for people at risk of homelessness or experiencing domestic abuse

The CSP has introduced two new sub-groups of the Community Safety Hub, with the aim of providing multi-agency support and intervention for individuals at an early stage.

The Housing Support Sub-Group has been established to provide a forum for information sharing and decision-making for more complex cases where a person has previously been identified as vulnerable and has caused anti-social behaviour to others, and where contact has been made with the local authority for homelessness advice or an application made to the housing register.

Where appropriate the individual concerned will be invited to attend these meetings in person to ensure they are engaged in the process and work together with professionals to determine their own action plan in a strengths-based approach.

The Domestic Abuse Sub-Group is for domestic abuse cases where the individual has contacted the local authority for homelessness advice or an application made to the housing register.

Joint working between relevant agencies support an informed assessment of risk levels and enable evaluation of appropriate measures and interventions to manage risk and explore the role of statutory homelessness functions and the housing allocation scheme.

'J9' Domestic Abuse training

World Cup domestic abuse campaign

The CSP delivered a social media awareness campaign during the 2022 football World Cup reaching more than 10,000 people.



The campaign targeted both victims and perpetrators to raise awareness of Domestic Abuse and promote the services available to keep victims safe and help perpetrators acknowledge and address their behaviour.

Research shows that there is an 38% increase in incidences of Domestic Abuse when England play if they lose and 26% if they win or draw.

There is a 47% increase in alcohol related Domestic Abuse cases on days England win and an 18% increase on days after an England match.

Posters were also created, distributed and displayed in licensed premises across the district; and ten paid social media messages were delivered via Facebook and Twitter ahead of, and after key moments of the tournament. More than 10,000 people were 'reached' through these messages, and 216 people actively engaged with the posts.

Moving Forward

Braintree District Community Safety Partnership has received a funding allocation of £17,739 for 2023-24 from the Office of the Police, Fire and Crime Commissioner for Essex (PFCC).

In 2023-24 the Strategic Priorities of Braintree District Community Safety Partnership will be:



These priorities, along with the core responsibilities of the CSP – to reduce crime and disorder, to reduce re-offending and combat the misuse of drugs, alcohol and other substances – will inform Braintree CSP's Action Plan for 2023-24.

The Partnership will address these priorities through the identification of agencies and resources that are best placed to respond and deliver improvements.
