- 4. The security cameras shall have been erected in accordance with the details submitted pursuant to 'discharge of conditions' application reference 13/00220/DAC granted on 13th February 2014.

- 5. The security fencing shall have been erected in accordance with the details submitted pursuant to 'discharge of conditions' application reference 13/00220/DAC granted on 13th February 2014.
- 7. The landscaping of the site shall be in accordance with the landscaping details agreed pursuant to 'discharge of conditions' application reference 13/00220/DAC granted on 13th February 2014, together with the details set out in the abovementioned Planning Statement dated March 2020 and Planting and Landscape Management Plan ref 2020 HIGHFIELDS 01 submitted 16th March 2020.

The additional landscaping (set out in the above-mentioned Planning Statement dated March 2020 and Planting and Landscape Management Plan ref 2020 HIGHFIELDS 01 submitted 16th March 2020) shall be carried out in the first available planting and seeding seasons.

Any trees or plants which die, are removed, or become seriously damaged, or diseased within a period of 5 years from the completion of the development shall be replaced in the next planting season with others of a similar size and species.
