#### 14 RECOMMENDATION FROM OVERVIEW AND SCRUTINY COMMITTEE 7<sup>TH</sup> MARCH 2018 – TASK AND FINISH GROUP REVIEW IN TO TOURISM IN THE BRAINTREE DISTRICT

**INFORMATION:** Members received a presentation from Councillor Mrs Pell, Chairman of Task and Finish Group Scrutiny Review into Tourism in the Braintree District.

Members were informed that the Task and Finish Group had met with several different representatives during their research sessions into tourism in the District and were advised about the potential economic impact of Tourism in the Braintree District. It was reported that the Braintree District offered rural villages, as well as Market Towns, and that gateways such as Harwich, Stansted, and the A12 offered huge potential. The Braintree District was also located geographically close to other tourist destinations such as Colchester, Maldon and South Suffolk.

It was reported that, in 2015, Tourism accounted for £179, 0000 per annum to the Braintree economy, and that this did not change significantly in 2016. The current economic impact of Tourism in the Braintree District was equivalent to 7% of the Braintree economy and 0.5% of total employment, a substantial number.

Members were informed that networking and marketing research was a valuable insight and many representatives had struggled with this due to financial and time limitations. A strong media presence was important, Social Media as well as in particular a website was invaluable as long as they were easy to navigate. It was reported that Braintree only had 520 serviced hotel rooms, which was a small amount to comparable District areas, these were predominantly 3 Star, and there was a distinct lack of boutique hotels and other accommodation types. This was a serious inhibitor to Tourism in the District.

**DECISION:** That Council agreed to refer the Task and Finish Scrutiny Review Report into Tourism Potential in the Braintree District report to Cabinet on 14<sup>th</sup> May 2018 for consideration and response.

**REASON FOR DECISION**: To enable the Task and Finish Group's report to be referred to Cabinet in accordance with the Procedure Rules for Scrutiny as set out in the Constitution.
