The Leader stated that he had appointed Councillor Bill Rose to act as a Non-Voting Deputy Cabinet Member to support the work of Councillor Tom Cunningham, Portfolio Holder for Economic Development. Councillor Rose would be invited to attend meetings of Cabinet and to take part in debate, but he would not have the right to vote. Whilst Councillor Rose would be engaged in the work of the Cabinet and the Economic Development Portfolio, he would not be able to make formal decisions, or exercise any delegated authority.

INFORMATION: The Leader of the Council announced his Scheme of Delegation for 2016/17 and the appointment and Terms of Reference of Cabinet Sub-Committees / Groups, as set out in a report attached to the Agenda, which were noted. 11 CONSEQUENTIAL AMENDMENTS IN RELATION TO THE LEADER'S SCHEME OF DELEGATION

INFORMATION: Members were advised that in response to the Leader's announcement regarding Cabinet Member Portfolios, the Scheme of Delegation and appointments to Cabinet Sub-Committees some consequential amendments were required to the Council's Constitution. These were set out in the Agenda report.

In particular, it was proposed that the appointment of Councillor B Rose as a Non-Voting Deputy Portfolio Holder should qualify for the payment of a special responsibility allowance in line with existing Deputy Portfolio Holders. This was currently £4,635 per annum. The Members of the Independent Remuneration Panel had been consulted and had agreed that this proposal was appropriate and that it should be a supported.

Following the decision to change the Mi Community Scheme to an individual Councillor-led scheme, the Leader had reviewed the name and Terms of Reference of the Mi Community Group. This would now be known as the Grants Panel. This would require a consequential amendment to the Member Allowances Scheme by changing the special responsibility allowance payment, currently £4,635, from the Chairman of the Mi Community Group to the Chairman of the Grants Panel.

DECISION:

- (1) That the creation of an additional Member's special responsibility allowance for a Non-Voting Deputy Portfolio Holder be approved.
- (2) That the amendments to the Constitution, as detailed in the body of the report, be adopted.

(3) That the Head of Governance be authorised to incorporate the changes within the Constitution and to make such typographical amendments as are necessary to do this.

12 APPOINTMENT OF COMMITTEES AND SUB-COMMITTEES

INFORMATION: Consideration was given to a report on the appointment of Committees and Sub-Committees, their size and political balance.

In an amendment to the report by the Leader Councillor Butland, it was proposed that the membership of the Overview and Scrutiny Committee should remain as 12 Members comprising 11 Conservative Councillors and one Labour Councillor and that Councillor Abbott's name should be removed from the proposed membership.

It was proposed that the membership of the Appeals Committee should be three Members (plus three substitutes) comprising one Conservative Councillor, one Labour Councillor and one Green Councillor and that Councillor Abbott should be a Member of the Committee and Councillor Tattersley a substitute Member.

Councilor Abbott spoke against the proposals.

- (1) That the political balance requirements be noted.
- (2) That the size of the individual Committees and Sub-Committees to be subject to proportional balance and the allocation of seats to political groups be agreed in accordance with the report, as amended below.
- (3) That the appointments to Committees and Sub-Committees, as set out in Appendix A to the report and as summarised and amended below, be adopted.
